President Hastings asked what the membership fee would be for Active Adults, it noted Active Adults would be free.

Trustee Morrison motioned, seconded by Trustee Hastings II to approve the mutually agreed partnership and terms between the Village of Orland Hills and the Tinley Park Bobcats Football, now formally known as the Orland Hills Tinley Park Bobcats Tackle Football Program, for the usage of Kelly Park and Sports Complex for the upcoming 2024 Football Season with official documentation forthcoming such as formal contracts and certificate of insurance per Assistant Village Administrator Tuma's memo dated 2/16/24 as presented.

Discussion regarding the partnership between the Village of Orland Hills and the Tinley Park Bobcats Football now formally known as the Orland Hills Tinley Park Bobcats Tackle Football Program was had. Trustee Kissane has concerns allowing a Tinley Park program to come into the Village. Trustee Hastings II commented historically this has been done for a non-for-profit organizations that will better our community; they have agreed to change the name to Orland Hills Tinley Park Bobcats and Orland Hills will be their home field. Trustee Hastings II noted there were multiple meetings to discuss the options and our Assistant Village Administrator was present during these meeting just like the discussions that took place with the Orland Park Pioneers; who at this time our current Village Administrator O'Neill was involved in. Trustee Morrison commented in years past we did not charge the Wolves usage fees for our fields which is the same agreement for the Orland Hills Tinley Park Bobcats; and when the Wolves were here the majority of the players were not Orland Hills residents. Trustee Hastings II noted this is to help them get established and we will revisit usage in the next two years. Trustee Kissane is 100% for a football program. Trustee Petrey commented he had concerns and those concerns were addressed at committee where he got them answered. Trustee Kissane asked who was paying for the equipment for the players. Trustee Hastings II commented we are helping with field usage. Trustee Petrey had concerns about field usage on the indoor turf. Assistant Village Administrator Tuma commented if there is a paying association for that timeframe, they would have the priority and the Bobcats are aware of this along with not pushing any of gym memberships out when they use the fitness center and turf for their drills/skills during the off season. Trustee Morrison commented the Village never paid for the equipment for the players and we allowed them to use the concession. President Hastings commented this is a great program coming to the Village and explained to the board and public how the Orland Hills Wolves came about almost 20 years ago. It was developed to help our children achieve a higher experience and opportunity right here in our town. President Hastings noted this is the same arrangement that was proposed to the Orland Pioneers a few years ago and asked Trustee Hastings II to explain. Trustee Hastings II explained to the board and public this was the same arrangement that was offered to the Orland Park Pioneers and the only request was to change their name to the Orland Hills Pioneers to incorporate Orland Hills into their name and their board voted it down. Trustee Hastings II noted the agreement will be reviewed again in 2026. President Hastings commented this is good for our town and the Village has never paid for player equipment. Trustee Kissane is not concerned about a football program for Orland Hills, she is more concerned that it was a Tinley Park program coming into the Village. Trustee Petrey had a concern about limited perimeters and appreciated everyone's concerns. Trustee Schmidt asked if Orland Hills residents would get a discount on the registration fees. Trustee Hastings II noted is currently a flat rate for everyone at \$350. President Hastings asked if there was any further discussion; and hearing none, a roll call was requested.
